2. Only written approval by the SCHOOL FTS Finance Team constitutes a commitment on the part of the school.
3. Financial aid is granted for one academic year only.
4. The parent(s) may be asked to come in for an in-person interview with the Finance Team.
5. Please attach your child's academic and (any) discipline records for evaluation by the School. A student receiving any financial aid must have a GPA of at least 3.0 and in good behavior standing.
6. Any incomplete application will not be considered.
7. Failure by the student and/or family to adhere to these conditions may result in aid termination.
8. A tuition discount may be given to the parents from Zakat funds who are eligible to receive zakat and whose income is below Federal Poverty Guidelines (FPG) of the Dept. of Health and Human Services:
